

**Information notice on the processing of personal data
in view of their transfer to Regnet**

The purpose of this document is to inform you on how First Bank S.A., with registered office in Bucharest, Sos. Nicolae Titulescu no. 29-31, sector 1, registered in the Trade Register under no. J40/1441/1995, with CIF 7025592 ("First Bank" or "Bank"), as an independent controller, processes your data in accordance with the legislation in the field of personal data processing, including the General Data Protection Regulation 679/2016 (GDPR).

In the context that you are the representative of a legal entity interested in the services of Regnet S.R.L., with registered office in Bucharest, Sector 3, Voronet Street no. 14, bl. D8, sc. 2, et. 2, ap. 26, registered in the Trade Register under no. J40/12350/2013, with CIF 32322748 (hereinafter referred to as "Regnet"), if you agree, the Bank will forward to Regnet your data mentioned below, so that it can inform you on how it can support you in setting up an entity of type SRL, PFA, PFI, II ("Legal Entity").

1. Personal data

The personal data that the Bank will transmit to Regnet are the following: name, surname, telephone number, e-mail address and the city where you are interested in opening the legal entity. The data that Regnet will receive from the Bank following your consent will be processed by the Bank in accordance with the provisions of the Information Notice on the processing of personal data by Regnet, available at www.regnet.ro/gdpr-app/.

2. Legal basis and purposes of the processing of personal data

Your personal data are processed:

- by the Bank, for the purpose of transmitting them to Regnet and for internal reporting on the cooperation with Regnet; and
- by Regnet, in order for Regnet to contact you and inform you on how it can support you in setting up a Legal Entity.

The legal basis for the processing is the basis of your consent, according to Article 6.1 lit. a) of the GDPR.

3. Duration of processing of personal data

Your data will be processed by the Bank for a period of one year after collection. If you withdraw your consent, your data will no longer be processed for the purposes mentioned above, without the withdrawal of consent affecting the legality of previous processing operations.

4. Recipients of personal data

Your data will be transmitted to Regnet.

5. Your rights and how you can exercise these rights.

As a data subject, you are entitled to the following rights provided for in Articles 15-22 of the General Data Protection Regulation: a) the right of access to personal data, b) the right to rectify data, c) the right to erasure of data, d) the right to obtain restriction of data processing, e) the right to data portability, f) the right not to be subject to an individual decision made exclusively by automated means, g) the right to withdraw your consent at any time, without any justification, without the withdrawal of consent affecting the lawfulness of the processing operation previously carried out, h) the right to apply to the courts or the ANSPDCP.

In order to exercise the rights provided for under points a) - g), you may submit a written request, dated and signed, sent to First Bank, at the following address.
