a) The maximum amount that can be withdrawn without an appointment is 5.000 EUR or equivalent;

b) The appointment must be scheduled at least 2 days in advance.

\*\*\* a) The commission is not applicable if the deposit represents a debt to the bank (e.g. loan payment, fees, etc.)

b) The fee does not apply in the case of banknotes cash deposits at MFM First Bank, where the maximum daily limit for cash deposits is 48,500 lei, equivalent in EUR/CHF.
